			Ensure participants undertake appropriate warm up and warm down activities as part of the session.

			Indoor Cave to be inspected by activity leader before activity commences.	
			 Participants briefed as to emergency procedure including use of buddy system if light fails and to identify closest emergency hatch in case of getting stuck. 	
			Emergency kit in area to access passage to remove panels if required.	
Participants' behavior	All	High	If in the opinion of the instructor the behavior of an individual or the group as a whole is not conducive to running a safe session then the activity session will be stopped and the person or persons causing concern removed.	
			 No person under the influence of alcohol or drugs should be allowed on the activity site. 	
Condition of the activity	All	Medium	Prior to session visually check to ensure Indoor Cave area is free of any materials and objects etc.	
			 Participants to remove hard / sharp objects from pockets prior to start. Safe box provided for these. 	
			 Any unsafe equipment must be removed and reported after the session. 	
			 Indoor cave helmet inspection sheet to be completed before and after each session 	
Equipment failure / fire	All	Medium	No mobile phones, lighters or matches permitted in cave.
