Inappropriate running of the activity	All	High	<ul style="list-style-type: none"> <li>All activity instructors to sign the risk assessment log sheet and document, their permit number and expiry date prior to the session starting.</li> <li>All activity instructors to have completed the Fanwood site specific activity training/familiarisation prior to running this activity.</li> <li>Activity instructors to ensure enough supervision is in place to monitor all aspects of the activity area for the size of the participating group.</li> <li>Safety briefing given at start of session.</li> <li>Activity Instructors to be mindful of the weather conditions and consider ending the session should the equipment become wet and slippery.</li> </ul>	
Injury to participants and instructors through incorrect use of equipment	All	High	<ul style="list-style-type: none"> <li>Good group management and monitoring of all aspects of the Activity area required by activity leader.</li> <li>Participants to be briefed in the introduction on uneven terrain and trip hazards.</li> <li>Appropriate footwear to be worn.</li> <li>Have participant's clean mud from shoes provided. Ensure shoelaces are tied securely.</li> <li><b>Participants to go under the cargo net not over, to prevent injury if the net moves.</b></li> <li><b>Care to be taken on other obstacles to ensure each person has time to complete and a "backlog" of people is not created</b></li> </ul>

Injury to participant(s) and instructor(s)	All	High	<ul style="list-style-type: none"> <li>Suitable clothing for weather conditions.</li> <li>If weather conditions are not conducive to safe sessions, limit time/change activity or reschedule.</li> </ul>	
Participants' behavior	All	High	<ul style="list-style-type: none"> <li>If in the opinion of the instructor the behavior of an individual or the group as a whole is not conducive to running a safe session, then the activity session will be stopped and the person or persons causing concern removed.</li> <li>No person under the influence of alcohol or drugs should be allowed on the activity site.</li> </ul>	
Strains and Sprains/Injury	All	Medium	<ul style="list-style-type: none"> <li>Safety briefing, warm up and stretching exercises prior to starting the activity.</li> <li>Demonstrate good technique, ongoing monitoring, and good group management to be maintained by activity leader.</li> </ul>	
Condition of the activity	All	Medium	<ul style="list-style-type: none"> <li>All equipment inspected prior to and after use and monitored during session.</li> <li>Damaged equipment to be reported.</li> <li>Participants shown how to correctly use equipment including manual handling.</li> <li>Monitor correct usage throughout activity.</li> </ul>	
Unauthorised use	All	Medium	<ul style="list-style-type: none"> <li>Adventure Trail to remain locked when not in use</li> </ul>	
Covid	All	High	<ul style="list-style-type: none"> <li>Government and scouting guidelines which are in force at the time the activity is run must be followed.</li> </ul>
