			Safety briefing given at start of session.	
			• Activity Instructors to be mindful of the weather conditions and consider ending the session should the equipment become wet and slippery.	
Injury to participants and / instructors through incorrect use of equipment	All H	High	Good group management and monitoring of all aspects of the Activity area required by activity leader.	
			 Participants to be briefed in the introduction on uneven terrain and trip hazards. 	
			Appropriate footwear to be worn.	
			Have participant's clean mud from shoes provided. Ensure shoelaces are tied securely.

Injury to participant(s) and instructor(s)	All	High	 Suitable clothing for weather conditions. If weather conditions are not conducive to safe sessions, limit time/change activity or reschedule. 	
Participants' behavior	All	High	 If in the opinion of the instructor the behavior of an individual or the group as a whole is not conducive to running a safe session, then the activity session will be stopped and the person or persons causing concern removed. No person under the influence of alcohol or drugs should be allowed on the stopped and the person or persons causing concern removed. 	
Strains and Sprains/Injury	All	Medium	 activity site. Safety briefing, warm up and stretching exercises prior to starting the activity. Demonstrate good technique, ongoing monitoring, and good group management to be maintained by activity leader. 	
Condition of the activity	All	Medium	 All equipment inspected prior to and after use and monitored during session. Damaged equipment to be reported. Participants shown how to correctly use equipment including manual handling. Monitor correct usage throughout activity. 	
Unauthorised use	All	Medium	Adventure Trail to remain locked when not in use
