			<ul> <li>Area to be check for debris or anything that could impede the safe running of the activity.</li> </ul>	
			<ul> <li>Maximum of 12 participants with a minimum of two leaders present.</li> </ul>	
			<ul> <li>One leader in charge to be located at the top of the run responsible for safety and management of the participants used the course.</li> </ul>	
			<ul> <li>A second leader to be located at the bottom of the slope to ensure that the run is cleared immediately and that the sledge is returned to the top of the slope OUTSIDE the main running area.</li> </ul>	
			Activity to be halted immediately if any person or animal stray into the vicinity of the run.	S

			<ul> <li>Participants to be given clear instruction on safe use of the sledges and run, and that anybody failing to obey the instruction of the leaders will not be allowed any further rides.</li> <li>Sledge to be checked before use for any defects and periodically during use. Any defective equipment to be removed immediately and reported.</li> </ul>		
Equipment prior to use	All	Medium	<ul> <li>Equipment to be checked regularly and particularly before use. Special attention to be given to loose or slack tracks, worn or missing trends or damage to the body of the sledge or grab handles.</li> <li>Tracks to be lubricated with bio-degradable oil</li> </ul>		
Injury to participant(s) and spectators	IIA II	High	Participants to remain behind running area with their sledges and will not proceed to moved forward or onto the slope until instructed.		
			<ul> <li>Riders to hold onto grab handles and keep their bodies within the confines of the sledge. Particular emphasis to be made regarding trapped finger in the track mechanism or sledges coming into contact.</li> </ul>		
			<ul> <li>There must be no attempt to hinder anybody on the run either by spectators or other users.</li> <li>There will be no throwing of objects at anyone on the run.</li> </ul>		
Storage of equipment	All	Low	<ul> <li>All sledges to be cleaned before being put back into storage.</li> <li>Any defects or damage to sledges must be reported.</li> </ul>		
Unauthorised use	All	Low	Equipment to be kept in locked store.
